Applications are invited from interested & eligible individuals fulfilling the eligibility criteria as laid down in the window advertisement for availing their services on re-employment basis initially for a period of one year in HPPTCL.

- He/ she will get the monthly salary on the basis of last pay drawn minus gross pension/EPF or minus EPF. Contribution by Deptt.
