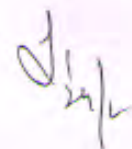

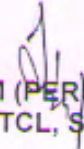

3. Contract Appointee so appointed under these rules shall be governed for regularization as per policy of Govt. of Himachal Pradesh issued from time to time. However, appointee will have no right to claim regularization.
4. Leaves shall be admissible to contract employees strictly in accordance to the H.P Government instructions regulating leaves of contract employees. Contract Appointee shall not be entitled to LTC/Medical reimbursement.

5. Un-authorized absence from the duties without the approval of the controlling officer shall automatically lead to the termination of the contract. Contract Appointee shall not be entitled for wages for the period of un-authorized absence from duty.
6. The contract Appointment is being made against requirement of HPPTCL and the Appointee can be placed at any working location within Himachal Pradesh. The transfer of Appointee during existing contract period will not be permitted from one place to another. However, the transfer can be considered at the time renewal of contract on need basis or on administrative grounds.
7. Contract Appointee prior to his/her joining will have to submit a medical certificate of his/her fitness from an Authorized Govt. Medical officer/Chief Medical officer concerned.
8. Contract Appointee if required to go on tour in connection with his/her official duties will be entitled to TA/DA at same rate as applicable to other regular analogous staff member of the category at the minimum of the pay scale.
9. Contract Appointee will be subject to conduct, Discipline and Appeal (CDA) Rules of HPPTCL.
10. The yearly performance of contract Appointee will be assessed through an appraisal system designed by HPPTCL and based upon performance during preceding years, the case for further renewal/extension will be considered.
11. Appointee will have to sign a contract agreement on joining with Sr. Manager (Projects), HPPTCL, PIU Rohru, Distt. Shimla (H.P).
12. The contract can be terminated by either party, after giving prior notice of 01(one) month and without assigning any reason. However, if an external training is provided to the contract Appointee, the Contract Appointee shall be asked to sign a bond to serve the HPPTCL for a particular period as a result of which the option with the Contract appointee to terminate the contract shall cease and this clause will stand amended to that effect.
13. You are required to produce original academic/technical qualification/certificate, degree, character certificate etc. along with matriculation/+2 examination certificate in proof of your date of birth/age along with attested copies to the Sr. Manager (Projects), HPPTCL, PIU Rohru, Distt. Shimla (H.P) for joining the post, and if any of the certificates/testimonies or information is suppressed by the contract appointee and come to the notice at later stage, the service as such shall be terminated and HPPTCL may also take any other action against the appointee as deemed fit. You will be required to furnish home town declaration certificate, movable property detail & employment of spouse detail etc.
14. You will furnish a declaration that you have only one living wife or are a bachelor.
15. Contract appointee shall be required to submit character verification/antecedent verification certificate from concerned police station.



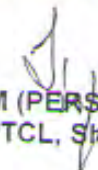
