



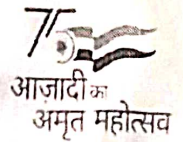



10. All other Charges i.e Road Tax, Permit Tax, Insurance Token Tax, salary and TA & DA of driver shall be borne by the vehicle owner.


