### OFFICE ORDER

We are pleased to offer you apprenticeship in HPPTCL subject to the following terms and conditions:

- 1.The duration of the apprenticeship shall be a period of 1 year from the date of joining.
- 2.This is not to be considered as employment and will not confer any right on the candidate to claim employment in HPPTCL.
- 3.The candidate can however apply for employment in HPPTCL when ever recruitment takes place as per rules of HPPTCL.
- 4.While due care will be taken to consider the interest and aptitude of the Apprentice, HPPTCL will have the right to attach the Apprentice with various offices in Corporate Office or in the field from time to time.
- 5.The candidate concerned can leave the apprenticeship by giving 2 days' notice and without assigning any reason.
- 6.HPPTCL can also terminate the apprenticeship by giving 2 days' notice.
- 7.A certificate will be rewarded on successful completion of 1-year apprenticeship, if no adverse reports are received.
- 8.A report of performance and conduct of the candidate will be obtained every month.
