Circular Regarding 2nd Sports Event

This is in continuation to circular issued vide letter dated 17.06.2023 and 26.06.2023, it is to inform that **the committee has decided to organize the 2nd Sports Event i.e. Cricket Matches on 24th - 26th February 2024. The following is intimated in this regard:**

1. Teams

6. Visiting players shall ensure that no official liability is affected keeping into consideration the time that will be involved in

5. It is further to intimate that participants shall be eligible for usual TA/DA as per entitlement.




