

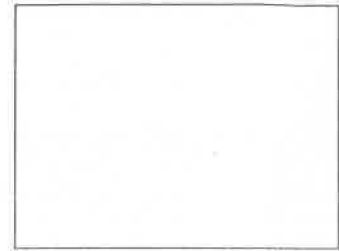

The Governor, Himachal Pradesh is pleased to notify the following terms and conditions for the appointment of Director in Himachal Pradesh Power Transmission Corporation Limited (HPPTCL):-

1	<b>Term</b>	The period of his appointment will be 5 years or 60 years of age, whichever event occurs earlier. The appointment may however be terminated even during this period by either side on 3 months' notice or on payment of 3 months' salary in lieu thereof. After the expiry of the first year, the performance of the incumbent will be reviewed to enable the Government to take a view regarding continuance or otherwise for the balance period of tenure.
2	<b>Eligibility</b>	i) The incumbent shall be a citizen of India. ii) Age: Minimum of 45 years and maximum 57 years as on 1 <sup>st</sup> January of the year in which the vacancy arises and the appointment shall be made through advertisement.
3	<b>Qualification</b>	<b>Director (Projects) in HPPTCL: -</b> The incumbent should be Engineering graduate in Electrical/ Mechanical Engineering with good academic record from recognized University/ Institution with at least 25 years post qualification experience in the field of Power Sector. He should preferably have worked in execution/ maintenance/ operation of transmission lines and sub-station projects for at least 10 years. 5	<b>Headquarter</b>	Directors headquarter will be at Shimla where the registered office/ headquarter of the company is located. Directors will be liable to serve in any part of the country at the discretion of HPPTCL.
6	<b>Dearness Allowance</b>	Directors would be paid Dearness Allowance in accordance with the new CDA schemes.

		<p>per HPPTCL Rules and as per entitlement.</p> <p>d) <b>Payment of House Rent Allowance-</b> If the HPPTCL is not in a position to arrange residential accommodation to Director out of its residential quarters or even on lease basis or if Director prefers to stay in a house taken by them on rent basis or make his/her own arrangement, he/she can be paid HRA as applicable to the Director of HPPTCL as per Rules.</p> <p>c) <b>Furnishing of residential accommodation: -</b> Director will be provided semi furnished accommodation with a monetary ceiling up to Rs.25,000/- (Rs. Twenty-five thousand only. Furnishing would remain to be property of the Company, i.e. HPPTCL.</p>
8.	<b>Conveyance</b>	As per company Rules enforced from time to time. The Directors shall be entitled for the Company's owned attached vehicle. Other Rules for entitlement shall be as per Rules of HPPTCL approved by the BOD from time to time.
9	<b>CCA</b>	Directors will be governed by the CCA Rules of HPPTCL.
10	<b>Leave</b>	Directors shall remain subject to the leave Rules of the HPPTCL. Managing Director will be the leave sanctioning authority.
11	<b>Annual Increment</b>	The Director shall be eligible to draw annual increment on the Anniversary date of his appointment in the scale and further increments on the same date in subsequent years. until the maximum of pay scale is reached.
12	<b>Medical facilities</b>	The Director shall be entitled to medical reimbursement and facility as may be applicable to the executives of HPPTCL.

13	<b>Telephone Facility</b>	As per company Rules of HPPTCL.
14	<b>Contributory Provident fund and Gratuity</b>	The Directors shall be governed for these benefits as per the Rules of HPPTCL.
15	<b>Productivity linked Per Incentive Scheme</b>	Wherever this scheme has been introduced by the HPPTCL, the benefits of incentive payments under the existing Productivity Linked Incentive Scheme would also be extended to the Directors.
16	<b>Other Benefits and perquisites</b>	The Director shall be entitled to Medical Facilities, Travelling Allowance, Leave Travel Concession, Disability Leave etc. in accordance with the Rules of HPPTCL.
17	<b>Conduct, Discipline and Appeal</b>	The Director shall be governed by the HPPTCL Conduct, Discipline and Appeal Rules. Following Disciplinary Authority will be the competent authority:- a. For imposition of minor penalties- Chairman. b. For imposition of major penalties- State Govt.
18	<b>Restriction on Joining private commercial undertakings after retirement</b>	After retirement from the Service of the Corporation, he/she shall not accept any appointment or post, whether advisory or administrative, in any firm or Company whether Indian or Foreign, with which the Company has or had business relations within one year from the date of his retirement, without prior approval of the Government. The term retirement includes resignation, but not the cases of those whose term of appointment was not extended by government for reasons other than proven misconduct. The term 'business relation' includes 'official dealings' as well.
19	<b>Other conditions</b>	a) The perquisites and allowances may be up to a maximum of 50% of the basic pay and payments over and above the ceiling of 50% should be entitled in the nature of performance related


