Extension of Timeline and Modification of Eligibility Criteria

With reference to tender **HPPTCL/PIU/KALA-AMB/TENDERS/VEHICLE/2025-26/05** for **“Providing 01 No. Mahindra Bolero Camper Diesel (4X4) 3+1seater, including driver & fuel to be used for O&M of various Transmission lines under Maintenance Hub Kala-amb with headquarter at O/o the Sr. Manager (Projects), HPPTCL PIU Kala-amb, Nahan, Distt. Sirmaur, (HP) for one year”** it is hereby notified that:

1. Extension of Deadlines:

Due to non-submission of required bids even after seven extensions, and in order to widen the scope of competition and ensure adequate participation, the due date for the availability of the tender, submission, and opening of bids is hereby extended as under:

2. Modification of Eligibility Criteria (Clause 10):

In order to widen the scope of competition and ensure adequate participation, **Clause 10 (Local Area & Bonafide Resident Requirements)** of the tender document is hereby **modified** as follows:

1. Original Clause 10:

The bidder should be in the vicinity of Projects area i.e areas under jurisdiction of PIU Kala-amb and the Bonafide resident of H.P (Documentary proof in this regard should be attached).

- a. **Local Area:** Local area means an area/tehsil in which the office/project for which the work is to be awarded falls. In case two or more locations in different Tehsils are involved in one tender or work contract, then all these will form the local area for that work contract.
- b. **Bonafide Resident:** A local bonafide resident means a person who is a bonafide resident, own land/house, owns a commercial establishment, or otherwise works for gain exercises a right of franchise and duly registered in the records of gram panchayat/municipality of the local area/office situated within Tehsil of the local area.

Revised Clause 10:

The bidder should be a **Bonafide resident of District Sirmaur, H.P.** (Documentary proof in this regard should be attached).

- a. **Local Area:** For this tender, the local area comprises **entire District Sirmaur, H.P.**, as the vehicle will be primarily stationed at PIU Kala-Amb and used for O&M maintenance activities across the district.
- b. **Bonafide Resident:** A bonafide resident means a person who is a bonafide resident, owns land/house, owns a commercial establishment, or otherwise works for gain, exercises a right of franchise and is duly registered in the records of gram panchayat/municipality situated within **District Sirmaur, H.P.**

2. Instructions for Bidders:

a) New Bidders:

New bidders meeting the revised eligibility criteria may now submit their bids by the extended deadline as per the revised schedule above.

b) Bidders Who Have Already Submitted:

Bidders who have already submitted their bids and meet the revised eligibility criteria need not resubmit. Their existing bids will be considered valid and will be evaluated along with new bids received.

However, if any bidder wishes to revise their bid, they may submit a fresh complete bid by the extended deadline. The revised bid must be submitted as follows:

Online Submission:

Bidders may withdraw their existing bid on the hp tenders portal and submit a fresh complete bid with all required documents.
