1. The General Manager (C&D), HPPTCL, Shimla-05 on behalf of HP Power Transmission Corporation Ltd. (HPPTCL) (alternatively referred to as "the Owner"/ "the Utility") invites sealed bids from eligible Bidders for the Project comprising "Design, Engineering, Manufacture, Fabrication, Testing at Manufacturers Works of Equipment and Materials, Loading, Transportation and Delivery, Unloading at Site, Necessary testing at site, Supervision of Erection of 07 nos. 53.33/66.67 MVA, 220/132/33 kV, Single Phase Auto transformers to 220/132kV GIS Sub Station to Paonta Sahib (4 Nos.) & 220/132kV AIS Substation Kala Amb (3 Nos.), District Sirmour and 03 nos. 53.33/66.67 MVA, 220/132/11 kV, Single Phase Auto transformers to AIS Sub Station at Kunihar, Distt. Solan, Himachal Pradesh."
2. Open national competitive bidding will be conducted in accordance with the bidding procedure and for procurement of the Works as per the requirements, specified in the IFB document (hereinafter also referred to as bidding document). Bidding is open to all the eligible Bidders as specified in the bidding document.
3. Bidders are advised to note the clauses on eligibility and qualification criteria specified in Section 3 of the bidding documents, to be eligible and to qualify for being considered for the award of the contract for procurement of the Works.
4. The bidding document is available online on <https://hptenders.gov.in/nicgep/app> from **06.02.2026 to 20.02.2026 (up to 04:00 PM)** on payment of cost of bidding document (Tender Fee) as indicated in the TABLE below. The prospective bidders would be responsible for downloading the bidding document and ensuring that any addenda/ corrigendum/ amendment/ clarification thereto available on the website is also downloaded and incorporated.
5. The bidding shall be conducted **under Single Stage Two-Envelope Bidding process with e-Procurement** followed by **e-Reverse Auction** as specified in Section 1 of the bidding

document. Under the Single Stage Two-Envelope Bidding process, the bidder shall not quote, disclose or submit its price in the Technical part (First Part/ Technical Bid) of its bid or in any other manner, whatsoever, except as part of the Price/Financial part (Second Part/ Price Bid) of its bid. In case of any non-compliance in this regard, the bids shall be out-rightly / summarily rejected.

6. Bid must be submitted online through the e-Procurement/ e-Tendering process specified in Section 1. Any bid or modifications to bid received outside the e-Procurement system will not be considered, unless otherwise specified in Section 1. The Employer shall not be held liable for any delays due to e-Procurement/ e-Tendering system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, it is the bidders' responsibility to verify the website for the latest information / updates related to this bidding and the Employer shall in no case be liable for any information not received by the bidder.
